

INSTALLATION STEPS

- 1. If present, lower vapor canister (black plastic box) attached to the passenger side frame rail, canister will be reattached later in the installation. <u>Note</u>: It is not necessary to disconnect vapor hoses.
- 2. Remove the rear most exhaust hanger and move muffler to one side. (See Rubber Isolator Removal Diagram)
- 3. Remove the rubber plugs from the bottom of the frame rails. Reverse fishwire 1/2-13 x 1 3/4" carriage bolts and SP6 spacer into frame rails, as shown. (See Reverse Pull Fishwire Technique)
- 4. Raise hitch into position and check for alignment with tow loop holes. Secure hitch to the carriage bolts with 1/2" flange nuts. <u>Note</u>: When raising the hitch into position the driver side plate will be to the outside of the tow loop and the passenger side plate will be to the inside of the tow loop.
- 5. Align holes in the side plates with the tow loop holes and slide SP25 spacers and 1/2-13 x 2" hex bolts into position, as shown. Secure bolts using 1/2" flange nuts.
- 6. Torque all 1/2" hardware to 110 ft-lbs.
- 7. Reattach vapor canister and exhaust hanger lowered earlier in the installation.
