

INSTALL TIME: 30 MINUTES

INSTALL NOTES:

No drilling required, fishwire fasteners into place.

INSTALLATION STEPS

Caution: Wiring harness is located inside passenger side frame rail, do not sandwich wires between frame rail and fasteners.

Note: If vehicle has a heat shield, remove one screw from the bottom of the frame rail so that models with bracket will mount flat.

- 1) Fishwire fasteners through access hole on underside of each frame rail. (**Note: Vehicles with weldnuts in frame use the M12 hex bolts and conical washers provided.**)
- 2) Raise hitch into position and install remaining fasteners through bumper mounting bracket as shown above.
- 3) Torque all 12 mm fasteners to 86 lb.-ft. and all 1/2" fasteners to 110 lb-ft.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
