

INSTALLATION STEPS

1. Raise hitch into position. Align rear holes in side plates with 1 1/8" round holes in rear of frame. On long bed models, forward most holes will line up with holes 16" forward of rear holes in frame.
2. Install hardware, as shown above. **Note:** 9/16" hardware should be located in vehicles rearmost mounting locations with CM-SP74 spacers. CM-SP1 spacers are used in middle holes and CM-SP6 spacers are used in forward most holes.
3. Torque all 1/2" hardware to 110 ft-lbs and all 9/16" hardware to 130 ft-lbs.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
